Today's News

Wow! A lot has happened since we winterized your pools and spas last fall. It's only February and we have a new president, economic trouble worldwide, failing banks and large businesses, job losses, declining housing values and foreclosures, investment loses and a general sense of pessimism. Guys like Bernie Madoff, Nick Cosmos and others, have devised diabolical schemes to steal billions of dollars from innocent people. (The Bible calls these deeds "having the *LOVE* of money"). Just a short time after some of the first stimulus money was given to banks and large companies, they told us, "We don't know where 350 BILLION went!" Ouch! As I understand, many congressmen from the House and Senate approved the 2nd stimulus bill (which is over a 1000 pages long) without reading it through first. But, congress now promises a watchful eye on that money. Many of Obama's handpicked cabinet members have money and legal problems that include unpaid taxes.
